Motion was made by Eric Barber and seconded by Sarah Willborn to approve previous minutes. Motion carried 4-0.

Chris Mulkey and David Alaman were sworn in.

Sabrina Gonzales for monthly trade days was not present, item was tabled.

Discussion of ARPA funds has been tabled until next meeting.


Abatement of properties was discussed.
