Changes to the Community Center plans were discussed. New building will be moved 5 foot forward to the North closer to the street. Also discussed 6x16 front sidewalk, 6x52 side entrance sidewalk, basketball concrete and fence, North sidewalk and crushed limestone for foundation.

CDC will pay for the limestone base foundation. Motion was made by Kelly Seales and seconded by Tish Perry. Motion carried 5-0.

CDC will pay for the patio extension. Motion was made by Tish Perry and seconded by Leticia Clemmer. Motion carried 4-1 with Kelly Seales against.

Buff Riverwalk executive rock and charcoal roof was chosen.

CDC discussed the Lil Sooper building. Bids will have a minimum bid of \$125,000.00 with a 2 year payout, after a successful 2 years of business the CDC will then sign over the deed. Building offered as is.

Sealed bids with business plan and performance bond will be accepted.

City will need to come up with an ordinance or contract to ensure that the building will always be used as a grocery store.

Motion was made by Kelly Seales and seconded by Tish Perry to place public notice in paper. Motion carried 5-0.

Motion was made by Tish Perry and seconded by Keaton Martin to allow Bruce Allen to seek bids to move the gate on the South side of the Lil Sooper building. Motion carried 5-0.

Motion to adjourn at 8:30 p.m. was made by Sharon Dodson and seconded by Jay Holt (City). Motion carried 4-0. Brandy Manning left meeting at 7:50 p.m.
