Michael Bruck couldn't make meeting but was able to call in. Maintenance Contract on the water tower would cost \$209,000.00 for a 5 year contract. Option #2 was \$300,544.00. This included interior and exterior. Company is out of Crawford, Tx.

Motion was made by Mark Richardson and seconded by Chris Mulkey to give Mayor Holt authorization to negotiate rate on water tower with AT&T. Motion carried 3-0. Linda Sjogren will contact AT&T about contract.

Motion was made by Chris Mulkey and seconded by David Alaman to approve the commercial rates as follows: 0-50,000 gals \$12.18 per thousand

51,000-99,000 \$13.18 per thousand 100,000.00 up \$14.18 per thousand Flat fee of \$24.18 effective Jan 2023 billing.

Motion carried 3-0.

Sign discussion has been tabled until January.

Sewer in the alley between Echols and Foster was discussed.

Chris Mulkey will research sound deadening panels for the community center.

Motion was made by Mark Richardson and seconded by David Alaman to approve the plan for splash pad and to authorize Mayor Jay Holt and CDC President Kelly Seales to execute the documents and contract. Motion carried 3-0.

Future agenda items: Water tower maintenance contract, marque sign, post office lease and water softener.
